The parties have effected a compromise and complainant has suffered a statement to the effect that the matter has been settled and a cheque bearing No.18274 dated 15.07.2020 worth Rs.50,000/- has been delivered to him by the respondent as full and final settlement. In these circumstances, he does not want to continue with this complaint and withdraws the same. He prayed for dismissal of the complaint as withdrawn by reserving his right to get it revived in case the cheque is dishonoured. Copy of cheque has also been placed on record.

In view of the fact that the matter has been settled between the parties and the statement of the complainant, the complaint is dismissed as withdrawn with the rider that in case the cheque is dishonoured, the complainant shall have the right to get this complaint revived by filing an application in that respect.
